After TechnoServe receives proposals and written evaluations are completed, the selected bidder will be notified. Commitments made by the bidder after selection, and final demonstration will be considered. The following points will be assigned to the proposals for evaluation purposes.

Performance Location

Virtual/remote.

Background and Objective

TechnoServe seeks a firm that can provide on-demand video editing services. Contractor would mostly use footage provided by TechnoServe, though may also need to integrate separate b-roll and/or music.

Founded in 1968, TechnoServe is a leader in harnessing the power of the private sector to help people lift themselves out of poverty for good. A non-profit organization working in 30 countries, we work with people to build a better future through regenerative farms, businesses, and markets that increase incomes. Our vision is a sustainable world where all people in low-income communities have the opportunity to prosper.

Contractor Tasks

Edit together footage into professional-looking videos with input from TechnoServe, applying titles, text, music, and other video elements as needed.

Deliverables

Videos as needed within a 2-year Master Services Agreement

Deliverable Acceptance Standards

The Consultant will engage with TechnoServe's Director of Communications and/or a designee who will review each deliverable and be the sole judge of adequacy. The contractor will be responsible for rectifying any reasonable requests from TechnoServe for changes, clarification, corrections, etc

Operation and Logistical Considerations

Structure of Agreement

This competitive bid process will result in TechnoServe signing a Master Service Agreement (MSA) with the winning vendor. The MSA will define the terms of the agreement for a 2-year term. As projects arise, fees and deliverables will be defined later in separate Task Orders under the MSA.

Provision of Footage

The footage for the final video will be provided by TechnoServe. Shooting of video footage is not needed.

Content of Proposal (Cont'd)

Payment Terms

Please include your payment terms in your proposal.

TechnoServe will give preference to any vendor that will accept net 30 payment terms upon invoicing.

Timeline and Office Hours

Please provide your firm's standard timeline for response and turnaround, along with office hours.

For planning and execution, it would be ideal for TechnoServe to have a full picture on when the bidding vendor is available to provide quotes on a given project/video, as well as the standard turnaround time (based on length of video).

Please include standard fees for rush delivery.
