Background

Botswana has experienced steady economic growth over the years underpinned by prudent economic management. As with many economies globally, the onset of COVID-19 slowed economic activity and the country experienced a negative economic shock as a result of the pandemic. The landlocked Southern African country is one of the largest producers of diamonds globally and its mining sector – the main contributor to the economy – suffered because of the pandemic. Other sectors such as tourism have also been severely disrupted and impacted by public health restrictions that had to be introduced in efforts to curb the spread of COVID.

In the second half of 2021, the negative impact of the pandemic on the economy began to ease. The global diamond industry was on a pathway to recovery and the country was recording improvements in economic growth outlooks. However, recovery is uneven across sectors and unemployment remains a challenge, particularly amongst the youth. For its part, the government has instituted a "Reset Agenda," setting out five priority areas for recovery and rebuilding. One of the priority areas is value chain development; unlocking more value in strategic sectors that include mining, tourism, agriculture, and education, with the aim of advancing economic diversification and youth empowerment.

Since 2014, the Government of the Republic of Botswana (GRB), Debswana, the De Beers Group, Anglo American and TechnoServe have partnered to deliver an enterprise and youth development programme in Botswana. The objective of the programme has been to enhance entrepreneurship, employment, and economic diversification through a variety of activity tracks targeted towards the youth and citizen-owned small, medium and micro enterprises (SMMEs).

Aiming to further boost economic diversification, improve the livelihoods of smallholder farmers and mitigate the food security risks, agriculture development has been identified as a priority sector within the partnership.

The dynamics of the agricultural sector in Botswana are quite unique when compared to their neighboring Southern African countries. Agricultural production only accounts for about 3% of Botswana's GDP, compared to an average of 15% in Sub-Saharian Africa. About 85% of the country's agricultural output is derived from livestock production, mainly beef, with a cattle population of more than 2 million. Subsistence farming is the norm across most of the other agricultural sectors and the country is highly dependent on the imports of staple crops – sugar, dairy, corn and wheat represent most of the imports, mainly from South Africa.

Project Objective and Deliverables

Technoserve will be running a diagnostics project with the objective of identifying the best opportunities to support the agricultural sector in the country and design an impactful and implementable intervention.

The fellow will work with TechnoServe's Strategic Initiatives team and lead the project execution, including conducting in-country research in Botswana, which will contribute to the project's overall deliverables.

The project's overall deliverable is a PowerPoint presentation (~50 slides) that diagnoses the key opportunities to boost the inclusivity of smallholder farmers in the commercial agricultural sector in Botswana, a prioritization of such opportunities and a design of an intervention to be implemented by the partnership. There will be intermediate deliverables that will contribute to the overall deliverable.

Proposed sub-objectives and elements of work are the following:

- Run primary and secondary research, and interview a significant number of local experts and stakeholders in the agricultural sector
- Identify priority set of opportunities with potential to support the agricultural sector in the country, with an special focus on increasing the inclusivity of smallholder farmers into the commercial value chains to boost their incomes
- Establish analytical framework for assessing relative attractiveness of options in terms of assessment criteria and prioritize the most compelling opportunities
- Calculate the business case of the key opportunities, including the size of the opportunity and investment required
- Design a specific and implementable intervention for prioritized opportunities, including the impact potential, the investment required, the implementation plan and the key partners to involve

Key activities and timelines

The project should conduct the core research and analysis, and deliver the diagnostics and the design of the intervention over a 16-week period.

Skills and Requirements

- Demonstrated research experience evaluating agricultural value chains utilizing both primary and secondary resources
- Professional experience in developing countries
- Demonstrated leadership skills, teamwork and relationship building
- Excellent written and verbal communication and interpersonal skills
- Strong computer skills, including MS Word, PowerPoint and Excel
- Able to work independently, flexibly and responsively
- Able to adapt to changing working conditions
- Able to prioritize and meet deadlines
- Professional level of spoken and written English

Logistics

The consultant will need to conduct primary research and interview relevant stakeholders in Botswana during at least 3-4 weeks. TechnoServe will pay the consultant on the basis of the deliverables described above. The project should start in September 2022.

The consultant will report into and have regular check-ins with TechnoServe's Strategic Initiatives team. The bulk of the consultant's work will be performed independently.

TechnoServe will cover travel-related costs including international airfare, in-country accommodation, in-country transportation, a per diem for living expenses, visas and vaccinations, and emergency evacuation insurance.
